OBRAS EJECUTADAS CON CARGO A LOS PRESUPUESTOS DE 2011 PARA RESOLVER LOS PROBLEMAS DE ABASTECIMIENTO DE AGUA, PRESENTADA POR D. MIGUEL ÁNGEL PALACIO GARCÍA, DEL GRUPO PARLAMENTARIO SOCIALISTA.

"En el programa Plan de Obras y Servicios 2011 (P.O.S. 2011) se licitaron 20 obras para los Ayuntamientos de Bárcena de Cicero, Bárcena de Pie de Concha, Campoo de Enmedio, Campoo de Yuso, Cillorigo de Liébana, Colindres, Guriezo, Laredo, Liérganes, Molledo, Peñarrubia, Piélagos, Potes, Rasines, Reocín, San Miguel de Aguayo, San Pedro del Romeral, Santillana del Mar, Saro, y Selaya con un presupuesto inicial de 4.014.114,79 euros y un presupuesto total de adjudicación de 3.164.054,99 euros, lo que supuso una baja media del 21%."
