OBRAS EJECUTADAS CON CARGO A LOS PRESUPUESTOS DE 2012 PARA RESOLVER LOS PROBLEMAS DE ABASTECIMIENTO DE AGUA, PRESENTADA POR D. MIGUEL ÁNGEL PALACIO GARCÍA, DEL GRUPO PARLAMENTARIO SOCIALISTA.

"En el Programa Plan de Obras y Servicios 2012 (P.O.S. 2012) se licitaron 23 obras para los ayuntamientos de San Roque de Riomiera, Valle de Villaverde, Ramales de la Victoria, Arredondo, Entrambasaguas, Castro Urdiales, Escalante, Noja, Argoños, Cabezón de la Sal, Mazcuerras, Ruiloba, Cabuérniga, Alfoz de Lloredo, Santa Cruz de Bezana, Cieza, Reinosa Valdeprado del Río, Hermandad de Campoo de Suso, Valdeolea, Pesquera, Santiurde de Toranzo y Villafufre con un presupuesto inicial total de 4.551.911,05 euros y un presupuesto total de adjudicación de 3.429.945,78 euros, lo que supone una bajada media del 25%."
